# **Business Multi Line Discount Terms and Conditions**

These terms and conditions apply to new and existing business customers who have a Qualifying Plan with Three and add one or more Additional Plans to the same business account. They apply in addition to the Terms and Conditions for using the Three network found at <u>Business terms and conditions | Three Business</u>

Unless otherwise indicated, defined terms in these Multi Line Discount Terms shall have the same meaning as given in the Terms and Conditions for Business Customers.

# **Qualifying Plans:**

Customers have a 'Qualifying Plan' if they have purchased a 12, 24 or 36 month: SIM only plan, device with airtime plans (excluding 12 month plans), data SIM plan, mobile broadband plan for MiFis and dongles or Business Broadband.

# Additional Plans:

Customers who have a Qualifying Plan can purchase up to a total account allowance of 499 additional plans ("Additional Plans") and receive up to 20% multi line discount on the Additional Plan/s:

- 1. All SIM only 12 and 24 month plans
- 2. All device with airtime 24 and 36 month plans
- 3. Mobile broadband 12, 24 and 36 month (MiFi) plans
- 4. Business broadband 12 and 24 month plans

The Qualifying Plan will not benefit from the multi line discount itself, but may benefit from other promotions and discounts. The Qualifying Plan in your basket will be selected based on the highest Monthly Charge out of all plans Customer is purchasing. If an Additional Plan is added to Customers basket which has a higher Monthly Charge then the Additional Plan will become the Qualifying Plan.

### Non-eligible plans and exclusions:

If Customer purchases a one month SIMO, or a 12 month device plan, it will not benefit from a multi line discount.

The multi line discount is applied to the Monthly Charge for the Additional Plan/s only and not applied to any other Charges incurred in connection with Customers Additional Plan.

### Important Information:

Customer may benefit from a multi line discount on up to 499 Additional Plan.

### Other information:

The multi line discount is available on purchases made through Three directly, it is not available through our channel partners or affiliates. Plans purchased through partners or affiliates may also not be used as a qualifying line.

If Customers Additional Plan benefits from a multi line discount, and Customer changes the price plan <u>within the Minimum Term</u> (but keeps the original Minimum Term end date), the multi line discount will continue.

The multi line discount cannot be used in conjunction with any other offers (with the exception in respect of a very limited range of compatible discounts). At the point of purchase there may be times when Customer is presented with the multi line discount when other discounts are also available. We will automatically apply the offer that provides Customer with the biggest savings over the duration of Customers Agreement.

At the end of the Minimum Term of Customers Additional Plan, the multi line discount will continue to be applied to any Additional Plan/s, unless or until Customer agrees to a new Additional Plan with a new Minimum Term or Customer ends the agreement.

# Removing the discount:

If Customer cancels the Qualifying Plan during the Returns Period (as defined in Three's Returns and Exchanges Policy found <u>here</u>) of the Qualifying Plan, we will not apply the multi line discount to Additional Plan/s unless Customer has a remaining Plan which can replace the Qualifying Plan.
